

This is to certify that at a meeting of the Court of Common Council, August 8, 2016, the following RESOLUTION was passed.



WHEREAS, The State Department of Emergency Services and Public Protection has notified the Department of Emergency Services and Telecommunications of its Fiscal Year 2016-2017 fund based on a per capita formula; and

WHEREAS, The City of Hartford provides a primary Public Safety Answering Point (PSAP) which meets the criteria specified in Public Act 96-150 in the Department of Emergency Services and Telecommunications; now, therefore, be it

RESOLVED, That the Mayor is hereby authorized to accept the FY 2016-2017 Department of Public Safety training funding in the amount of \$12,470.50 to provide training for dispatchers assigned to the Department of Emergency Services and Telecommunications.

WHEREAS, On June 27, 2016, the Court of Common Council passed a resolution authorizing the Mayor to enter into a \$300,000 contract with COMPASS Youth Collaborative to implement the Peacebuilders Initiative; and

WHEREAS, That resolution authorized a one-year contract with options to renew for three one-year terms; and

WHEREAS, It is the desire of the Administration to amend said resolution to delete the renewal options and require a competitive bid process for fiscal years beyond 2016-17; now, therefore, be it

RESOLVED, That the first resolved clause in the June 27, 2016 resolution be deleted; and be it further

RESOLVED, That the Court of Common Council hereby authorizes the Mayor to enter into a one-year contract in FY 2016-2017 with COMPASS Youth Collaborative, Inc. for implementation of the Peacebuilders Initiative, in the amount of \$300,000, which funds are available in the General Fund Budget of the Department of Families, Children, Youth and Recreation – Division for Youth, and subject to the availability of funding; and be it further

RESOLVED, That the Department of Families, Children, Youth & Recreation will conduct a formal bid process in January 2017 to select a contractor for subsequent fiscal years.

This is to certify that at a meeting of the Court of Common Council, August 8, 2016, the following RESOLUTION was passed.

WHEREAS, Oscar Lopez Rivera, a Puerto Rican born activist who is a decorated Vietnam War veteran who lived in Chicago and organized education and social projects benefiting his community; and

WHEREAS, Oscar Lopez Rivera has been a fervent believer in Puerto Rican independence and has been critical of the U.S. government's role in the governance of Puerto Rico; and

WHEREAS, Between 1981 and 1983 Lopez Rivera and 13 other men and women involved in the movement for Puerto Rican independence were convicted of seditious conspiracy and sentenced to 55 years in prison even though Lopez Rivera has consistently maintained that he was not involved in any acts that harmed anyone or took a life; and

WHEREAS, In 1999 President Bill Clinton offered to commute Lopez Rivera's sentence as well as the sentences of all but two of his co-defendants, concluding that the sentences received by Lopez Rivera and his co-defendants were "out of proportion to their crimes"; and

WHEREAS, Lopez Rivera refused to leave any member of his community behind and therefore declined the President's offer of clemency; and


WHEREAS, Many prominent politicians and world leaders like Desmond Tutu, former President Jimmy Carter and the United Nations Decolonization Committee have asked for Lopez Rivera to be released from prison; and

WHEREAS, All the other men and women sent to prison along with Lopez Rivera have since been released and are living productive and responsible lives; and

WHEREAS, The largest sub-group among Latinos in the City of Hartford is Puerto Rican and there is overwhelming support in the Puerto Rican community for Lopez Rivera's immediate release; now, therefore, be it

RESOLVED, That the Hartford City Council calls upon President Obama to grant clemency to Oscar Lopez Rivera so that he is immediately released from prison.

WHEREAS, Hartford Communities That Care is a not for profit organization that has lead the Hartford crisis response team since 2005; and

WHEREAS, In the year of 2016 Hartford Communities That Care, Inc. (HCTC) will respond within 24-48 hours to each call to assess the mental health and other crime related needs of crime victims; and

WHEREAS, HCTC will provide a follow-up call and/or visit to each client and/or family to inquirer about any additional assistance the family might need related to the crime with follow-up conducted twice within the first 6-months after the crime has occurred; and


WHEREAS, HCTC will convene bi-monthly meetings of the Hartford Crisis Response Team(HCRT), which would include members of the mental health establishments, Hartford Police Department (HPD), Hartford Public Schools, St. Francis Hospital and Medical Center, Hartford Peace Builders, members of the Faith Community and other stakeholders interested in assisting the mission of the HCRT; and

WHEREAS, HCTC agrees to create and maintain a data-base of all clients referred to the HCRT. This data base would include the types of services for which each client was offered, accepted/received and what if any challenges they might have encountered related to services associated with the crime; and

WHEREAS, HCTC will utilize the Results Based Accountability (RBA) framework to evaluate and measure effectiveness of the Hartford Crisis Response Team; now, therefore, be it

RESOLVED, That the Court of Common Council authorize the Mayor to identify and insure disbursement of \$40,000 in unspecified funds to provide to Hartford Communities That Care.

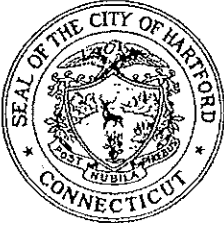


WHEREAS, The Construction Contract Taskforce will meet monthly on the third Monday of the month starting the month following the adoption of this resolution; and
