


This is to certify that at a recessed meeting of the Court of Common Council, May 21, 2007, the following RESOLUTION was passed.

RESOLVED, That the Court of Common Council requests the Mayor to change semi-annual to quarterly tax payments as follows:

Said taxes shall become due on July first, two thousand and seven and payable on said date in whole or in equal quarterly installments from that date, namely: July first, 2007, October first, 2007, January first, 2008 and April first, 2008, except that any tax not in excess of one hundred dollars (\$100) shall be due and payable in full on the first day of July, 2007, and except that any tax on a motor vehicle shall be due on July first, 2007 and payable in whole or in equal semi-annual installments from that date, namely: July first, 2007 and January first, 2008, and except that any tax in excess of one hundred thousand dollars (\$100,000) shall be due on July first, 2007 and payable on said date in whole or in equal semi-annual installments from that date, namely: July first, 2007 and January first, 2008.

In the event that a court of competent jurisdiction enters a final judgment that the aforesaid provision concerning the semi-annual collection of taxes is illegal and void, said collection provision shall be considered separable from the remainder of the Tax Levy Ordinance and the said taxes shall be due and payable in accordance with the following provisions: said taxes shall become due on July 1, 2007, and payable on said date as stated above in whole or in equal quarterly installments from that date, namely: July first, 2007, October first, 2007, January first, 2008 and April first, 2008.
